INTRODUCTION

CIMAR, a brand of Edappal Hospitals, an exclusive fertility center, offers a complete range of services in gynecology, obstetrics, fertility treatments, breast health, fetal medicine, Neonatology, pediatrics, etc. The hospital was awarded NABH accreditation in 2018 and was the first to get an ISO certification in the district of Malappuram.

B.Sc. Nursing

OVERVIEW OF B.Sc. NURSING COURSE

B.Sc. Nursing is a four-year full-time degree program comprising eight semesters, specified by the Indian Nursing Council (INC) & Kerala Nurses and Midwives Council (KNMC) and affiliated to Kerala University of Health Sciences, (KUHS), which prepares nursing graduates qualified to practice nursing and midwifery in a variety of settings in either public/ government or private healthcare settings.

NUMBER OF SEATS: 40 Seats per Year

- Government Quota: 20 seats (50 % of total seats)
- Management Quota: 14 seats (35 % of total seats)
- NRI Quota: 6 Seats (15% of total seats)

ALLOTMENT OF SEAT

1. Government Quota: 20 seats (50 % of total seats)

Government seats are those in which the Director of Medical Education makes allotments. Admission to these seats will be made based on merit. Admission process of allotment to Government merit seats (50%) under Edappal Hospitals – Nursing College will be done by the Director, LBS Centre for Science & Technology, under the supervision of the Director of Medical Education, as per the G.O (MS) No. 75/2018/H&FWD dated, 18/05/2018. Candidates are requested to visit the official website of the LBS Centre www.lbscentre.kerala.gov.in for details

2. Management Quota: 14 seats (35 % of total seats)

Other than Government seats (35%), these are the seats against which the Edappal Hospitals – Nursing College will make allotment. There will not be any type of reservation in the Management seats. Candidate shall pay the Tuition fees and Special fees, fixed by the Government. The eligibility for admission is the same as for the Government quota and the candidate will be selected on a merit basis. Candidates can apply online through the college website www.ehnc.in.

3. NRI Quota: 6 Seats (15% of total seats)

NRI details with **Embassy Attestation** and Supporting documents as per the directives issued by the ASC in various dates and the Government order G.O (Ms) No. 243/14/H&FWD dated 06.08.2014 & 375/2020/H&FWD dated 28.06.2024.

ELIGIBILITY FOR ADMISSION

As per Academic Regulations of course in force from time to time

- Candidates who have passed Higher Secondary Examination of the Board of Higher Secondary Education, Kerala, or examinations recognized equivalent thereto by KUHS with 50% in aggregate for Physics, Chemistry and Biology/ Physics, Chemistry, Biology and minimum pass mark as per respective boards for Physics, Chemistry, Biology and English in the qualifying examination.
- Candidate who completes 17 years of age as on 31st December of the year of admission
- Candidate shall be medically fit to undergo the course.
- As per the Regulations published by Kerala University of Health Sciences (KUHS) from time to time.
- Relaxation of marks for SC/ST and SEBC candidates as per Govt. Norms.

- Application for admission and prospectus are available ONLINE through the college website. Visit www.ehnc.in for details.
- The application fee is Rs.1000/- for all candidates, payable through online. The candidate should have a valid e-mail id and mobile number.

1. After entering all necessary information and uploading the mark list, necessary documents, photo, application fee transfer details, signature of parent/guardian and applicant, pay the application fee online.
2. Submission of more than one application by a candidate will lead to rejection of the candidature.
3. Application fee once remitted will not be refunded in any circumstances. Incomplete/belated applications will be rejected.

Duration of the course

Duration of the B.Sc. Nursing course shall be four years, which is a credit and semester-based program, comprising of eight semesters including an internship. The maximum period to complete the B.Sc. Nursing course successfully shall not exceed twice the actual duration of the course (Eight years)

SELECTION OF CANDIDATES

Selection of candidates will be based on a merit list prepared based on the marks obtained in the plus two or qualifying examination. Candidates should bring all the documents in original for verification at the time of admission. Any false information will lead to cancellation of admission.

Preparation of merit list

Marks of Physics, Chemistry and Biology in Higher Secondary Examination

- ❖ Will be considered for the preparation of the merit list. If there is a tie, marks for Biology will be taken, followed by Physics and Chemistry. If all these are equal Date of Birth of the candidate will be considered i.e., with the person of higher age getting preference over the younger.
- ❖ CBSE/ ICSE Senior Secondary Examination marks will be equated with Higher Secondary marks of Kerala syllabus by approved normalization process.

ADMISSION

- Selected candidates will be informed the date and time of interview and admission, in due course, through the website
- Candidates are requested to visit the www.ehnc.in regularly for notifications and announcements.

- Selected candidates for admission under the Management quota are requested to remit the fee into the college account through bank transfer and must bring the fee transaction details.

All the selected students should get themselves vaccinated against Hepatitis B before admission. Certificates to the effect should be produced at the time of admission or before the commencement of the course.

Physical Fitness Certificate (Certified by a Registered Medical Practitioner) should be produced at the time of admission or before the commencement of the course.

All other fees will be as per order no FRC 50/22/B.Sc/P.BSc/M.Sc/NURSING Fee regulatory committee for medical education in Kerala.

DISCONTINUATION

- A candidate who gets allotment and admission to a course through the Directorate of Medical Education, Kerala for the Academic Year 2026 - 27 will be eligible for full refund of fee remitted and he/she need not pay any liquidated damages up to the date fixed by Government.
- Candidates who express their intension not to pursue studies in the Nursing College before the last date fixed for closure of admissions will be eligible for refund of the 1st year tuition fee and other fees except admission fee. They will be eligible to get back their original certificates handed over to the college at the time of admission. In the case of students who leave the College at the time of admission. In the case of students who leave the college midway, the right of the management for liquidated damages, if any, from such students will be determined by the competent “Civil Court”.
- Candidates admitted against Government seats in Govt./Management seats in Edappal Hospitals Nursing College who discontinue the course after the first academic year, are liable to pay liquidated damages equal to the total amount of tuition fee payable for the remaining

year(s) of study. The discontinuation from the course and cancellation of the admission shall be subject to the legal and factual scrutiny of the AFRC/Court of Law when any complaint is submitted before the Committee on such matter.

- EXAMINATION
- Regular University Examination is conducted at the end of each semester and supplementary examination as notified by KUHS. Examination fees shall be remitted by the candidate as stipulated by the University & college from time to time.

ELIGIBILITY FOR APPEARING EXAMINATION

A candidate must have a minimum of 80% attendance in theory and practical in each subject to appear for the University Examination. A minimum of 80% attendance in all the non-exam going subjects in the concerned semester is essential for registering a candidate for the university examination.

The candidate must secure 50% marks for internal assessment in theory and practical, wherever applicable to be eligible to appear in the university examination of the subject.

RULES AND REGULATIONS

1. Students shall strictly observe professional conduct and high standards of discipline and Each student should report for class / clinical at the specified time
2. Students should maintain decorum and dignity in the College, Hospital & Hostel.
3. As per clause 7 of the Rules and Regulations of the University and Judgment of Honourable Courts regarding the conduct of students on campus, the management has the right to stall organizational activities of students' organization directly or through their member students in campus. An undertaking to this effect be given by the students and their parents at the time of admission.
4. Ragging in any form is strictly prohibited in the College and Hostel campus. If any incident of ragging occurs, strict action will be taken as per the latest direction of the Hon'ble Supreme Court.
5. Use of mobile phones by the students is strictly prohibited in class, clinics and during working hours.
6. Any type of indisciplinary behaviour will be considered as serious offenses
7. Any change in the contact address / telephone number should be informed to the College immediately
8. Students should inform class coordinator / concerned teacher about any inability to attend classes and should submit the leave letter on time.

UNIFORM

Students must strictly follow the dress code in class and clinical areas as specified by the institution.

HOSTEL

Hostel facilities are available for female students. The annual hostel fee is Rs. 45,000/-, it may change according to the fluctuations of prices of commodities in the market.

- Admission to College Hostel will be according to the availability.
- The whole year Hostel fee should be remitted before the starting of every Academic Year.
- Hostel's Caution deposit (One Time) is Rs. 10,000/-. (Refundable at the end of stay subject to no dues certificate).
- Hostel Policy should abide by all the Hostel's inmates. Students are to follow the dress code strictly in hostel campus as specified by the institution.

MESS FACILITY

- Hostel inmates will get a mess facility.
- Mess fees will be collected according to the fluctuations in the prices of commodities in the market.
- The Mess/Canteen dues for the current month will have to be settled before the 5th of next month.
